# Accomplishments/Changes in 2021

- County roads designated:
  - Six miles of Cty Road W in the Town of River Falls
  - Cty S east from 290<sup>th</sup> Street to 150<sup>th</sup> Avenue in the Town of Maiden Rock
  - Cty AA three tenths of a mile in Town of Maiden Rock south from 20<sup>th</sup> Avenue to the Pierce/Pepin County line
  - Cty SS four miles in the Town of Maiden Rock from Lund east to the Pierce/Pepin County line
- Worked security at Pierce County Truck & Tractor Pull at the Pierce County Fair for fundraiser
- Doubled the club membership years 2020-2021
- Repaired ATV/UTV trail on Richardson property by Spring Valley
- Bay City authorized ATV/UTV's on all roads with traffic at 35 mph or less
- Village of Maiden Rock authorized ATV/UTV traffic on all streets
- Pierce County ATV/UTV Association filed for tax exemption status 501(c)(3)
- Requested more ATV/UTV routes in the Town of Diamond Bluff
- Fundraising through meat raffle and rides
- Printed new ATV/UTV maps

# ATV Routes Requested for 2022

# **First Route Request**

<u>Town of Isabelle</u> CTH EE from 170<sup>th</sup> Avenue to Hwy 35

Working on gaining access into Bay City businesses and the park.

# Second Route Request

 $\frac{\text{Town of Trimbelle}}{\text{CTH K from 810}^{\text{th}}} \text{Street West to 820}^{\text{th}} \text{Street} \\ \text{CTH K from 430}^{\text{th}} \text{Avenue South to 360}^{\text{th}} \text{Avenue} \\ \text{CTH K from 340}^{\text{th}} \text{Avenue to 840}^{\text{th}} \text{Street} \\ \end{array}$ 

This route will allow Town of Trenton and Trimbelle access to other areas of Pierce County. They will be able to visit food and fuel locations.

# Preferred route (safest) on CTH K, 430<sup>th</sup> Avenue to 840<sup>th</sup> Avenue – less turns and good site at intersections.

# **Third Route Request**

Town of Oak Grove CTH QQ from 570<sup>th</sup> Avenue to 1090<sup>th</sup> Street

Residents will be able to access other parts of Town of Oak Grove to avoid higher traffic in other areas.

## **Fourth Route Request**

<u>Town of Trimbelle</u> CTH OO from Hwy 10 South to 500<sup>th</sup> Avenue CTH OO from 450<sup>th</sup> Avenue South to 430<sup>th</sup> Avenue

This will help reduce and manage ATV/UTV traffic and dust problems for area residents.

## Fifth Route Request

Town of Trimbelle CTH O from 480<sup>th</sup> Avenue South to 430<sup>th</sup> Avenue

This will help reduce and manage ATV/UTV traffic and dust problems for area residents.

## Sixth Route Request

Town of Union CTH S from 370<sup>th</sup> Avenue to 180<sup>th</sup> Street

This will provide multiple routes into Plum City from Pepin and Dunn counties. Multiple routes reduce traffic, making them much safer for ATV/UTV travel.

## Seventh Route Request

Town of Maiden Rock CTH UU from CTH U to CTH SS

This will provide multiple routes into Plum City from Pepin and Dunn counties. Multiple routes reduce traffic, making them much safer for ATV/UTV travel.
