Treasurer's Report was given by Tina Huppert. Motion to approve the Treasurer's Report by Ron Wilkens, second by Sharolyn Johnson. Motion passed.

Old Business:

Town of Isabelle wanted 2 miles access and was on the agenda for the meeting tonight and was expected to pass.

President Larry Johnson reported on the Richardson property there are piles of wood and we can leave them to rot down, and there are two piles of dirt on the north end we can use to divert water going down the trail.

President Larry Johnson attended the Highway Committee meeting and requested the following roads to be opened for ATV/UTV travel:

- East on Cty Tk N to Hwy 63 from 610<sup>th</sup> Street
- 2 miles on Cty Tk HH east from Cty Tk CC to Nugget Lake Park
- 1 mile from Ct Tk X north on Cty Tk S to 70<sup>th</sup> Street
- 1 mile on Cty Tk BB south from 570<sup>th</sup> Avenue to State Tk Hwy 72
- ½ mile on Cty Tk CC north from 370<sup>th</sup> Avenue to 390<sup>th</sup> Avenue

Discussion took place regarding opening these roads.

New Business:

President Larry Johnson announced in Elmwood access to the gas station is not available due to sewer construction.

The Christmas party was discussed. Motion by Sharolyn Johnson, second by Tina Huppert, to have the Christmas Party at Clyde's Bar and Grill and all paid memberships by December 31<sup>st</sup> will receive a free hamburger and fries. Motion passed.

2015 membership renewals will be sent out in November. Sharolyn Johnson thanked Ron Wilkens for getting a business sponsorship from the Sandbar in Elmwood.

President Larry Johnson announced access to Woodville will be available when roads are signed in Town of Eau Galle from April 15<sup>th</sup> to November 30<sup>th</sup>. All roads will be open, but this does not include the Wildwood Trail.

Town of Trenton requests for opening Cty K in Hager and Cty VV will not be requested at this time due to improper road use. The Town Chairman will be working with the Pierce County Recreation Officer to solve these issues.

The Pierce County ATV Association will probably not be doing security at the Pierce County Fair next year as the Pierce County Fair is planning to merge the truck and tractor pull into one night. This is a major fundraiser so hopefully we can get more business sponsors.

Motion by Tina Huppert, second by Ron Wilkens, to purchase \$25.00 Gift Certificates for Arneson Insurance, Chad Westfield, Jim Schaffner and Mary Ann Richardson as a thank you for use of their property for ATV/UTV use. Motion passed.

Ron Wilkens reported 12 machines participated on a recent ATV ride from Wilson, to Elmwood, Eau Galle, Weston and back to Wilson.

The next meeting will be on November 17th at 6:00 p.m. at the Longbranch in Elmwood.
