**Old Business:**

Thank you to Paul Frandsen and his son for moving the rocks on the Richardson Trail. President Johnson reported he has a chunk of cement he will take down next spring and add beside the rocks.

The Town of Union opened all town roads and signing will be done in April of 2019. It is a one year temporary ordinance and hours of operation will be one hour before sunrise and 1 hour after sunset.

President Johnson asked if we wanted to have a meeting in Plum City to get business and individual memberships and volunteers to help sign roads. Motion by Darren Place, second by Tina Huppert to move the March Meeting to Molly's in Plum City. Motion passed.

Progress of storage units in Hager City was discussed and will know more when things develop regarding an ATV/UTV trail.

**New Business:**

President Johnson reported he will be gone for January and maybe February meetings. Darren Place and Sheldon Huppert can go to the Finance & Personnel Committee meeting and County Board meeting for ATV routes.

St. Croix ATV/UTV Association will sell tickets for the Moose Lodge Brunch again this year.

ATV Safety Class will be mandatory for children under 16 years old. They can not take the class online.

Plans are in progress for the Gandy Dancer State Trail to open to all ATV/UTV's.
