President Larry Johnson reported the Pierce County Board of Supervisor's amended the Park Ordinance to make ATV route on County P from 50th Street to 250th Avenue (70 Street). The Pierce County ATV club will be responsible for the bill for signing.

President Larry Johnson reported that Hartland passed the ATV Ordinance on the first reading. Sheldon Huppert reported that Chad Westfield will open his land to ATV use parallel to County V, so we can cross County V and travel down 620th Street .

The Pierce County ATV maps are being worked on yet. Will need to add the Town of Hartland roads and the route on CTH P to 250th Avenue. There was also a delay because Jill Sears had a death in the family.

President Larry Johnson was asked by the St. Croix County ATV Club if the Pierce County ATV Club would help with parking at the St. Croix County Fair in Glenwood City if they need help. We will wait for more details from them.

Galen Langer made a request asking Pierce County to open ATV Route on N from 610 Street to Lawton. The next meeting will be on May 19, 2014 at 6:00 p.m. at the Longbranch in Elmwood.

Jerry Punches reported there will be an ATV Trail Ride from Ellsworth to Iron River, leaving on Wednesday, May 21st and returning on Sunday May 25th. The first night will be spent in Shell Lake. For more information contact Jerry at 715-781-3815.
