The meeting was called to order at 6:00 p.m.

Estimated end of ride will be about 5 p.m. Don suggested to bring along a gallon of gas since it is so expensive to purchase in Edgewater, and bring along snacks or a lunch as there are picnic areas. President Larry Johnson informed the club that Scott Jones signed up to do security at the Tractor Pull Friday night at the Pierce County Fair so volunteers will be needed to work.

Ruth Esanbock informed the club members that gravel/fill will be put on railroad bed portion of trail in Spring Valley. It was mentioned that some of the Valhalla trails will be closed due to purchase of property.

New ATV maps were discussed. Jill Sears from Designs by Jill is working on the map now. The map will be 11" X 17" at \$1.80 each, with a set-up fee of \$50. Motion by Don Fuller, second by Tina Huppert, to order 200 maps with a \$50 set up fee for \$410 plus tax. Motion passed. Motion by Ruth Esanbock, second by Don Fuller, to charge business sponsors \$1.00 for each map, with an option that any money collected be returned to the club, or they can keep it. Don Fuller volunteered to make up donation boxes that will hold the maps and money for business sponsors.

The next meeting will be on the 4<sup>th</sup> Monday, June 23<sup>rd</sup> at 6:00 p.m. at Clyde's Corner in Beldenville.

Motion by Sharolyn Johnson, second by Ron Wilkens , to adjourn the meeting at 6:35 p.m. Motion passed.
