The Pierce County ATV/UTV Association wants to open 690th Avenue from the western border to 950th Street so the Town of Oak Grove can cross Cty E. A resident was going to the Town Board meeting to make a request to open routes but was not on the agenda. Discussion took place about signage as the Town of River Falls already has an ordinance. Motion by Everett Muhlhausen, second by Sheldon Huppert, to pay for signs for the Town of River Falls if routes are opened. Motion passed.

The Town of Oak Grove has had some complaints about ATV riders and have threatened to close down some routes. Sheldon Huppert and President Johnson will attend the Town Board meeting tonight. Discussion took place.

President Johnson reported there will be no Traffic Safety Meeting until September.
