The Sand Bar in Elmwood requested Pierce County ATV trail maps and a donation box but are not business sponsors. Motion by Tina Huppert, second by Jerry Johnson, that in order to have maps they must be a business sponsor. Motion passed. Ron Wilkens will take a membership form and maps and a donation box and see if they would like to become a sponsor.

More maps need to be printed. Motion by Tina Huppert, second by Toni Fuller, to approve \$100 for printing more Pierce County ATV maps. Motion passed.

Vice-President Darren Place opened nominations for Treasurer. Sharolyn Johnson nominated Tina Huppert, Toni Fuller second. Everett Muhlhausen moved to close nominations, second by Toni Fuller. Motion passed with a unanimous vote.

Vice-President Darren Place opened nominations for 3 positions for the Board of Directors. Jerry Johnson, Everett Muhlhausen and Don Fuller accepted. Tina Huppert moved to close nominations, second by Sharolyn Johnson. Motion passed with a unanimous vote.

Ken Majeski reported that our website Go Daddy will be up for renewal in September. Motion by Darren Place, second by Everett Muhlhausen, to renew the Go Daddy account and authorize Ken Majeski to pay for the renewal through his credit card and be reimbursed by the club. Motion passed.
